IV. Committee Reports

1. Fundraising - Nothing to report for the remainder of this year.

2. Communications - Secretary Erin Appl took a moment to say farewell to the Senior Class and reviewed all the BIG projects that their class was apart of:

2020-21: Outfield fence replacement (\$45,000), Replacing turf in the batting cages (\$10,000), Updating & new concrete in the bullpens

2021-2022: Batting Cage Turtle (6,000), Bullpen Video System (\$4,300), Batting Mats (\$1,500), Pitching Machines (\$3,000)

2022-2023: Home Plate Halo (\$26.500), Mound & Infield Dirt Redo (\$6,500), Sound System for the field (\$5,000), THE **Performance Development Center**!!!!! (roughly \$50,000 was the booster portion along with inside equipment purchases)

2023-2024: Conex box for storage (\$6,000), Concession upgrades (\$2,000), Outfield regraded (\$7,000), still to be installed the Right Field Fence

- She went on to thank past and present Booster Club Members as these improvements would not be possible if it weren't for each group fundraising and working to make our program better. She also looked to the younger classes to carry on the tradition of leaving Dragon Diamond better than how it was when you came into the program.
- 2. Concessions -Elena Kivett reported that we are ready to host a playoff game. We are looking for volunteers to help run it so Varsity can watch the game.
- 3. Merchandise Amy Kiemsteadt reported that Playoff Shirts will be coming by USPS at any minute. She will communicate drop offs and pick ups once they are in.
- 4. Special Events Carolina Rodriguez reported this is our last special event of the year. President Bob Slocum thanked her and her family for making tonight a special event and cooking all the food!

VI. Consideration of New Business

1. President Bob Slocum proposed By-Law changes:

1.2 - Any By-Law change discussed by the Executive Board will need to be brought to the Baseball Booster Club body of members for a final discussion and vote. "By-Law changes will

only be approved through a general vote of the Baseball Booster Club body."
